A Message from the President - Brian Mroczek

As I'm sure you're all aware, Betsy DeVos was sworn in as the 11th Secretary of Education. Known for her unfavorable views of public education, as well as her stance on vouchers and school choice, her confirmation was contentious from the start. After voting, the Senate was evenly split. This caused, for the first time ever, Vice President Pence to cast the deciding vote in favor of DeVos. Although the outcome was not what many of us in

education had hoped for, it was exciting and encouraging to see the enthusiasm it created amongst members of NYSUT and the OTA.

There is another cause coming in November that we must all be aware of and this one may be even more dangerous. Appearing on the ballot this November will be a question asking if you believe there should be a revision of the State Constitution. We do not want this to happen. Any revisions to the Constitution could affect our retirement system, our right to negotiate, and everyone's right to a free and public school system. Other things such as libraries, State parks, and workers' compensation could come under attack as well. It will appear as a question...

Ballot Question: "Shall there be a convention to revise the constitution and amend same?"

Your Answer: "NO"

You will be receiving information in the coming months. Please feel free to share it with anyone. Let them know this is not only an educator's issue, but everyone's issue.

We have begun the process of awarding our annual OTA Scholarships. Any OTA member may nominate a current senior for consideration. 

TALES FROM THE CRYPT

OREA MEMBERS MARCH

Many of our members took part in Women's Marches in various locations on January 21. Gloria Wilkins and Pat Albaugh were among those who took a NYSUT-sponsored bus from East Syracuse. Pat filed this report:

Signs, Signs, Everywhere there's signs...they caught our eyes as we walked and slithered and darted and sidestepped our way with the hundreds of thousands of Sisters and Brothers. Preserve Our Rights. Our Bodies, Our Minds, Our Power. Make America Integrate Again. Black Lives Matter. Real Men Support Gender Equality. Our Rights Are Not Up For Grabs, and Neither Are We. Todos Somos Immigrantes. Protect The Dreamers. This Is Just A Warm-up. There was cleverness galore: We Shall Overcomb. Super Callous Fascist Racist Extra Braggodocious. A little girl rode on her dad's shoulders carrying a sign she had obviously made: just a whole lot of Crayon scribbling. Very cute. We even spotted a Hi Mom.

Of course the real story is what those hundreds of thousands of signs were attached to. Everybody was there. Families, with Mom or Dad pushing the youngest in strollers. (I don't know how they did it...think State Fair on megasteroids.) Actually there were many wheels trying to roll along. People in scooters and wheelchairs, several elderly women being pushed by younger, stronger women or men, perhaps their last chance to speak up for rights they may have been fighting for their whole lives. People with those scooters you use after having foot surgery or breaking an ankle.

People of all colors and races and ethnic groups. We thought the crowd was a bit "whiter" than we would have predicted, but there was plenty of diversity. I'm willing to bet that every state in the Union was represented. We talked to people from Massachusetts, Pennsylvania, Vermont, New Hampshire, Georgia, and took a pic of a group with a sign Montana Women For Social Justice.

There were plenty of celebrities on hand, but we were so far adrift in the sea of connected humanity that we couldn't see a Jumbotron, let alone the speaker's stage. As we walked, we joined in the chants random groups were leading, so we felt that we expressed ourselves and had a chance to yell and clap over and over again.

Definitely one of the words of the day was politeness. We couldn't believe with all the people, all the careful pushing to get from one place to another, we were flooded with, "Excuse me," "Oh, I'm so sorry," "Yikes, I didn't mean to step on your foot," etc. etc. So impressive! We didn't notice much visible police presence inside the rally area, but as we left and started the walk to RFK Stadium and the buses, we saw plenty. So many people were greeting the officers, thanking them, wishing them well...and they were returning the smiles and thanking us for coming. Wonderful!

We stopped in a pub for a beer and some lunch and watched CNN for a while. We saw reports of the marches in Boston, New York, Hartford, LA, Chicago and Paris. We got text and FB reports from friends who marched in Seneca Falls and Plattsburgh and Sarasota. We looked at each other and kept saying, Wow...we were part of something really big.

As the bus left DC and started the long ride home, we took to our phones to see what was being said, how it was being reported, and to listen to the speakers that we couldn't hear in person. We checked with different groups and made plans to keep active, to stay involved, and not let this be a one-time event. So far we are following through.

Why did people march? So many reasons. The 27-year old niece of a friend said it very well: We are marching because our friends and neighbors may be deported, excluded from bathrooms, denied medical treatment, forced to bear children, barred from marrying, harmed by institutional racism, stripped of environmental protections, and denied access to a decent education. That pretty much covers most of it. As my favorite sign of the day said, with many arrows radiating to the end of the poster board: I'm With Her.

Service Salary Adjustment

As per our contract, Teachers with at least ten (10) years of service to the Oneida City School District

shall be eligible for the service salary adjustment of \$180 per year of service to the O neida City School District. They may apply for this adjustment at any point beyond the completion of the tenth (10th) year. Such amount shall be pro-rated for teachers working less than full time. Notice of the intent to elect such salary adjustment must be provided to the Superintendent <u>not later than April 1st</u> of a given year for such adjustment to become effective in the following year
